



Pharmasave “Love Local” Contest

Official Rules and Regulations

NO PURCHASE NECESSARY. The Pharmasave “Love Local” Contest (the “Contest”) is open only to Canadian residents who are 19 years of age or older at the time of entry, excluding residents of the Province of Quebec, Northwest Territories, Nunavut, and Yukon.

Please read these Official Contest Rules (the “Contest Rules”) before entering. By entering or attempting to enter the Contest, you are deemed to have read, understood, and agreed to be bound by these Contest Rules and by the decisions of Pharmasave Drugs (National) Ltd. (the “Sponsor”), which are final and binding in all respects. The Contest is sponsored and administered by Pharmasave Drugs (National) Ltd., 8411 – 200th Street, Suite 201, Langley, BC, Canada, V2Y 0E7.

1. CONTEST PERIOD

The Contest begins on April 7, 2026, at 12:01 a.m. Pacific Daylight Time (PDT) and ends on April 28, 2026, at 11:59 p.m. PDT (the “Contest Period”). The Sponsor’s computer is the official timekeeping device for the Contest.

2. HOW TO ENTER

NO PURCHASE NECESSARY.

To enter, complete and submit the official Contest entry form hosted on RafflePress during the Contest Period. Each entry form must be completed in full (the “Entry Form”), including name, email address, mobile number and postal code, and must be received before the expiry of the Contest Period. Once submitted, each Entry Form becomes the sole and exclusive property of the Sponsor and shall not be acknowledged nor returned. In the course of filling out an Entry Form, each Entry Form must include all information requested on the online form. Please carefully read the Entry instructions on the Contest website. An eligible entrant who completes the Entry Form will receive three (3) Entries into the Contest (an “Entry”).

Entries must be received during the Contest Period. The Sponsor is not responsible for late, lost, misdirected, incomplete, illegible, or technically corrupted entries.

The Sponsor reserves the right, in its sole discretion, to disqualify any entrant or Entry if it is found to be incomplete, submitted by unauthorized means, contains false or misleading information, or otherwise does not comply with these Contest Rules.

3. ELIGIBILITY

You are not eligible to enter if you are:

- An employee, officer, director, or agent of the Sponsor, its affiliates, subsidiaries, advertising or promotional agencies, or any party involved in the development or administration of the Contest.
- A member of the immediate family (spouse, parent, sibling, or child) or household of any such employee Groups, associations, corporations, or organizations may not enter.



4. LIMIT

There is a limit of one (1) Entry per person during the Contest Period.

5. RANDOM DRAW AND WINNER CONFIRMATION

On or about May 11, 2026, ten (10) eligible entrants (the “Selected Entrants”) will be selected by random draw from all eligible Entries received during the Contest Period.

The Selected Entrants will be contacted using the email address or phone number provided on the Entry form.

To be declared the winner, the Selected Entrants must:

- Correctly answer a skill-testing mathematical question without assistance
- Complete and return a Release of Liability and Consent to Publicity form within seven (7) business days of notification

If the Selected Entrants cannot be contacted, fails to respond, fails the skill-testing question, or fails to return the required documentation within the prescribed time, the Sponsor may, in its sole discretion, select an alternate entrant.

Odds of winning depend on the total number of eligible Entries received.

6. PRIZE

There are ten (10) prizes to be won.

The winners (10) each will receive:

- One (1) \$50.00 Pharmasave gift card
- One (1) \$50.00 gift card to a local business of choice
 - The business of choice must be eligible to be considered a local business as determined by the Sponsor
 - Eligible local businesses include but are not limited to local spas, local salons, local coffee shops, local pet stores, local jewelry stores, and local bookstores



- Ineligible local businesses include but are not limited to a chain with more than 3 locations, a pharmacy, a grocery store with a pharmacy within its' store, a liquor store, and a cannabis store
- The contest Sponsor will ensure adequate efforts are made to obtain a digital or physical gift card from the local business, but if not possible, alternative local business options may be suggested for the \$50.00 Gift Card by the contest Sponsor
- Gift cards may be available for pick-up only from the local business or the closest Pharmasave location to the winner, which will be the responsibility of the winners to pick-up within a reasonable timeframe as determined by the contest Sponsor

The approximate retail value of the total Prize per winner is \$100.00 CAD. The approximate retail value of the total contest prizes of the ten (10) winners is \$1000.00 CAD.

The Prize must be accepted as awarded and is not transferable, assignable, or exchangeable. No substitutions except at the Sponsor's discretion. The Sponsor reserves the right to substitute the Prize or any component thereof with a prize of equal or greater value if necessary.

The Prize is non-refundable. The winner is solely responsible for any costs not expressly described herein.

7. CONDUCT

By participating, entrants agree to abide by these Contest Rules and the decisions of the Sponsor, which are final and binding in all matters relating to this Contest.

The Sponsor reserves the right, in its sole discretion, to disqualify any entrant found to be violating these Contest Rules, tampering with the entry process, or acting in an unsportsmanlike or disruptive manner.

8. RELEASE OF LIABILITY AND CONSENT TO PUBLICITY

By entering the Contest, entrants:

- Confirm compliance with these Contest Rules



- Release and hold harmless the Sponsor and its affiliates from any liability arising from participation in the Contest or use of the Prize
- Consent to the use the following information from the contest entry form: their name, city of residence, why they love their community, their closest Pharmasave store and the name of their favourite local business for publicity purposes without further compensation, unless prohibited by law

9. LIMITATION OF LIABILITY

The Sponsor is not responsible for:

- Any technical malfunction, system error, or transmission failure
- Any lost, delayed, or misdirected Entries
- Any injury, loss, or damage arising from participation in the Contest or use of the Prize

10. GENERAL

This Contest is subject to all applicable federal, provincial, and municipal laws. The Sponsor reserves the right to amend, suspend, or terminate the Contest at any time for any reason.

All Entries become the property of the Sponsor and will not be returned.

This Contest is void where prohibited by law.

11. PRIVACY

The Sponsor collects personal information solely for the purpose of administering this Contest. No marketing communications will be sent unless consent is given.

12. GOVERNING LAW

This Contest is governed by the laws of the Province of British Columbia and the federal laws of Canada applicable therein. All disputes shall be resolved exclusively in the courts of British Columbia.
